Grade School

Kindergarten 5 years by 9/30

Preschool students must be fully potty-trained unless there is a medically diagnosed reason why toilet training would be significantly delayed or never obtained.

No Pull-Ups are allowed.

Please note that entrance into the Early Childhood Center does not guarantee entrance into the grade school (kindergarten). Additionally, ECC classes are subject to change if classes are not full.

NEW STUDENT REQUIREMENTS

Birth/Baptismal Certificates

Grade school (K-8) and ECC students must present their original birth certificate and, if Catholic, a copy of their baptismal certificate.

Health Forms

ECC and Kindergarten students must have a physical examination within 12 months prior to the first day of school and proof of adequate immunization.

Grade school students (grades 1-8) must provide the school with a completed physical examination form and proof of updated immunizations.

Attendees should arrive promptly at 9:00 a.m. for this structured program. You will have an opportunity to meet the principal and ECC director, ask questions regarding our curriculum and school, and receive a tour of the school from student volunteers.



REGISTRATION

⇒ Registration for all **returning** students and siblings of returning students is due on **December 2, 2019**.

⇒ Registration for **Blessed Sacrament parish families is January 14-16, 2020**. A registered parishioner is one who has completed the proper paperwork at the parish office and who receives church envelopes.

- Priority is based on longevity of parish membership.
- Registration forms can be printed from our website or obtained from the school office between 8:30 a.m.-4:00 p.m.
- Registration forms received after 4 p.m. on the last day will be on a secondary parish waiting list in the order in which they are received.

⇒ Registration for **non-parishioners** (on a first-come, first-served basis) is **January 21-22, 2020**. Catholics who are non-parishioners at Blessed Sacrament will need to provide written proof of current parish registration to be given priority over non-Catholic families.

- Office doors open at 8:00 a.m.
- Registration begins at 8:30 a.m.

All new K-8 and transfer students must have a complete application, and must undergo Assessment Testing prior to final acceptance.

*Upon acceptance, registration fee (also technology fee and workbook fee for grades K-8) must be paid by due date. First month's tuition is paid in April. Prompt payment is required to continue enrollment.

***All tuition/fee payments are non-refundable.**

Sibling Preference

To receive a sibling preference, a new registrant for the ECC must have a sibling who is enrolled in either ECC or the grade school for the current year and who will be enrolled for the coming year.

A new registrant for the grade school must have a sibling who is enrolled in the grade school for the current year and who will be enrolled for the coming year. Priority is given to registered parishioners.

EXTENDED DAY PROGRAM FEE SCHEDULE

A yearly non-refundable fee of \$35 per new student or \$25 per returning student must be paid when the application for enrollment is submitted. (Maximum fee of \$75 per year per family.)
